In response to the advertisement inviting Expression of Interest (EoI) for the above mentioned package published in 2 dailies on 21/11/2024 and SDF has received 34 EoIs within the deadline on 7/12/2024. The evaluation committee of SDF has evaluated the EoIs based on the ToR & set criteria for short-listing. It is mentioned that 7 out of 34 EoIs have fulfilled the requirements and finally shortlisted as per the ToR & set criteria followed by the World Bank guideline and PPR-2008.


